RULES & REGULATIONS - REMEMBER TO ENTER FROM TRINITY GATE ONLY!

1. Entries due Sunday, September 6th, 2026.
2. Absolutely **NO REFUNDS for any reason after Tuesday, September 8th, 2026.** Draw will be posted on website.
3. Contestants must be no older than (19) years as of January 1st, 2026, to compete in rodeo events. Proof of birth and guardian's driver's license must accompany entry or the entry is considered invalid.
4. Waivers will need to be signed for EVERY WARM BODY on the grounds. THIS WILL BE AT CHECK IN, AN ADULT MUST BE THERE TO SIGN THE WAIVERS!!
5. GROUND RULES MEETING 30 MINUTES PRIOR TO ALL PERFORMANCES, PLEASE ATTEND BEFORE COMPETING. PARENTS OF MINORS PLEASE ATTEND AS WELL. IF YOU DID NOT ATTEND THE MEETING, NO EXCUSE FOR NOT KNOWING THE RULES COVERED AT THE MEETING OR ON THIS SHEET.
6. NO RE-RIDES IN PEEWEE EVENTS.
7. AFTER INITIAL ENTRY TO THE EVENT YOU MUST HAVE YOUR BACK NUMBER AND WRIST BAND ON AT ALL TIMES WHILE ON THE RODEO GROUNDS.
8. During competition back numbers MUST be worn or contestant will be DISQUALIFIED.
9. DRESS CODE: contestants must wear western attire in arena AND track while on horseback/competing at rodeo. Failing to comply will result in DQ. Western Attire consists of cowboy hat or helmet, buttoned up long sleeve shirt, western pants and boots. This includes anyone assisting inside arena or track.
10. Awards as follows: Buckles for first in all events. ALL AROUND SADDLES AND RESERVE ALL AROUND BEST EVER PADS FOR YOUTH, JUNIORS, & SENIORS BOY/GIRL IN EACH DIVISION. Awards based on points won. Points based on a 10,8,7,6 ...(yes this is correct). Points will be given to first through ninth place on a boy/girl scale in each event Youth - Senior Divisions.
PEEWEE AWARDS SUNDAY AFTER THE CONCLUSION OF THE PEEWEE EVENTS Boys & Girls will be completing together with 1 set of points. We will award an ALL AROUND SADDLE & RESERVE ALL AROUND BUCKLE along with Event Buckles to the winner of each peewee event.
11. Sunday approximately 30 minutes after the rodeo we will be presenting event buckles and All-Around awards to the contestants near the Secretary Office.
12. GRIEVANCE PROCEDURE: **Contestants ONLY** must address all questions or problems to the Arena or Track Directors. Parent or other interested Person, who gets involved with the event director, judges, or other rodeo official, runs the risk of having the person whom they are trying to assist get DISQUALIFIED.
13. All-Around tie breaker: 1. Most money won. 2. Entered in two or more events but winning the most money in a single event.
NOTE: Ground split money goes to Scholarship Fund, will not be posted toward All-Around.
14. 60% Payout after stock and secretary fees.
15. **Chute Dogging:** Will be out of Bucking Chute. **If you participate in Chute Dogging you CAN NOT participate in Steer Wrestling and vice versa.**
16. **Team Ropers:** MUST ROPE WITHIN AGE GROUP – NO AGING UP! Confirm partner BEFORE entering. No refunds if partner fails to enter. We will NOT find you a partner or call you if your partner does not enter. If your name is not listed on the draw in team roping your partner did not enter. Jr/Sr are allowed 3 loops with a 30 second time limit. Each contestant is allowed 1 go within their age limit. Must dally, face & be tight.
17. **Youth 6-9 Sled Roping:** Sled will be pulled by a four-wheeler, 30 Second Time Limit. Heading and heeling will be done separately (no partners). Can enter both heading and heeling 1 time. 1 Loop, no rope barrier but horse's butt MUST be touching

the back of the box before the contestant nods their head – Failure to be touching back of the box will result in 10 second penalty. Heading: You must have your slack pulled for time to stop, 3 legal head catches. Heeling: You must be dallied for time to stop. 1 leg is a 5 sec penalty.

18. **Youth 6-9 Breakaway: Sled Roping:** Will be pulled by a four-wheeler. 1 Loop and must be roped before the marker at the end of the arena. Horse's butt MUST be touching the back of the box before the contestant nods their head or results in 10 second penalty. Rope must be tied on and have a flag. NO ROPE BARRIER.

19. NHSRA Rules will be followed in Barrel Racing, Pole Bending, Goat Tying, Breakaway Roping, Steer Riding. – **PLEASE SEE NEW 2024 HIGH SCHOOL RODEO RULES FOR BREAKAWAY**

20. **If you are competing in the Boy's Breakaway you CAN NOT enter the Boy's Calf Roping and vice versa.**

21. **Calf Riding:** Age 6-9 and Chute Run. 6 Second Ride & Score, Must wear protective gear – Helmet and Vest.

22. **Mutton Busting:** 5 & Under, Chute Run. 6 Second Ride & Score, Must wear protective gear – Helmet and Vest.

23. ****PeeWee Single Stake – Horseback**** Contestant MUST ride in stirrups that fit them and must have control of their horse. If the arena director or judge thinks the saddle or horse pose a safety risk, the contestant may be unable to participate in this event. Lead line is allowed, however, contestants who participate as lead line contestants will automatically place behind contestants who compete unassisted. Contestant will be considered "assisted" if a helper holds onto the reins or leads the horse with reins or lead rope. **THIS IS THE ONLY SPEED EVENT & AGE DIVISION THAT CONTESTANTS MAY SHARE A HORSE.**

24. **Stick Horse Barrel Race:** Cloverleaf barrel pattern, two rights-one left, or two lefts-one right. 5 seconds added for knocked down barrel. A disqualification if you go off pattern.

25. **Goat Undecorating:** Time will start when contestant crosses the line. Contestant must take ribbon off the goat's tail and carry it back to the finish line in order for the time to stop. If the contestant crosses the line without the ribbon they will receive a NO TIME.

26. **Dummy Roping:**

- * 3 Legal Head catches
- * Fishing is allowed but not off of the dummy's whole body.
- * Slack must be pulled tight
- * Contestant must stay behind the line; they cannot stand on the line or they will be disqualified.
- * All contestants get 1 loop. Best comes back for sudden death each round(s).
- * If you catch you move to the next round. If you miss you are out.
- * Judges have final say!

27. You will be disqualified for sharing horses in the same age group in Pole Bending, Single Stake or Barrel Racing only regardless if it is boy/girl, boy/boy, or girl/girl.

28. No day of sign-ups on either day of the rodeo.

29. All contestants shall comply with the rules. Any unsportsmanlike conduct will result in disqualification. Judges will make the final determination.

30. No exhibition rides allowed due to insurance.

31. All Stalls, RV's, & Shavings must be paid for - Contact Melissa Budden @ 530-520-8730 for any special requests.

32. **ABSOLUTELY NO TENT CAMPING ALLOWED**
